Clean

Contains completed provider files, without alerts, which can be quickly decided in bulk by the Medical Director, per the network requirements.

Leveling Review

Contains completed provider files, with alerts, that do not merit Credentialing Committee discussion for decision. However, these files may be escalated to the Credentialing Committee for discussion at the discretion of the Medical Director.

Committee

Contains completed provider files, with alerts, that meet the established escalation criteria and merit Credentialing Committee discussion before reaching a decision.
